## CAMPUS COMMUNITY NOTICE

Federal legislation known as the "Campus Sex Crime Prevention Act" requires states to obtain information concerning registered sex offenders enrolled or employed at institutions of higher education and make this information available to the institution's police department or other appropriate law enforcement agency having jurisdiction where the institution is located. The Kansas Bureau of Investigation has been designated as the state agency that will provide this information to the institutions of higher education in Kansas.

The "Campus Sex Crime Prevention Act" (CSCPA) also enacted amendments to the Higher Education Act of 1965 and the Family Educational Rights and Privacy Act of 1974 (FERPA) that require the institution of higher education to advise the campus community where the information on registered sex offenders can be obtained. Under CSCP A and FERPA guidelines, Kansas State University-Salina Security Department has established the following to provide the campus community access to this information.

1. A logbook will be maintained at the Security office listing those individuals identified by the Kansas Bureau of Investigation as registered offenders who are either employed or enrolled at Kansas State University- Salina. Information contained in the logbook shall consist of all information available as provided under the Kansas Bureau of Investigation Registered Offender List.
2. Within the Security department web page (<http://www.sal.ksu.edu/security/index.html>) an addition will be added titled "Federal Sex Crime Prevention Act". This segment of the sight will contain this community notice letter, a direct link to the Kansas Bureau of Investigations web page (registered offender database), and additional information as warranted. The KBI Registered Offender page permits one to search the offender list by name, city, county, or zip code.
3. Access to the KBI Registered Offender web page may also be accessed through the Kansas State University Police Department main campus web page (<http://www.k-state.edu/police/>).
4. A copy of FERPA and US Attorney General Guidelines for implementation of the "Campus Sex Crime Prevention Act" will be available at the Security office for public viewing.

A general community notice will be sent by electronic mail at such time as changes or additions are made to the offender list.
